**Sub: - Non-applicability of SEBI Circular dated 26<sup>th</sup> November 2018 with regard to Fund raising by issuance of debt securities by Large Companies.**

Dear Sir/Madam,

This is with reference to SEBI Circular No. SEBI/HO/DDHS/DDHS-RACPOD1/P/CIR/2023/172 dated October 19, 2023, read with Chapter XII of SEBI Operational Circular No. SEBI/HO/DDHS/P/CIR/2021/613 dated August 10, 2021, and SEBI Circular No. SEBI/HO/DDHS/CIR/P/2018/144 dated November 26, 2018, regarding the framework for fund raising by issuance of debt securities by Large Corporate Entities (LCs). The total outstanding long-term borrowings of the Company are less than ₹1,000 crore as at March 31, 2026. Accordingly, the Company does not meet the criteria specified under Clause 3.2(b) of the aforesaid SEBI Circular dated October 19, 2023, for identification as a 'Large Corporate'.
