

Dear Shareholder,

**Sub.: Notice for Transfer of Equity Shares to the Investor Education and Protection Fund (“IEPF”)**

This is to inform you that pursuant to the provisions of Section 124(6) of the Companies Act, 2013 (“Act”) read with the Investor Education and Protection Fund Authority (Accounting, Audit, Transfer and Refund) Rules, 2016, as amended from time to time (“IEPF Rules”), all shares in respect of which dividend has not been paid or claimed for seven (7) consecutive years or more are liable to be transferred to the Investor Education and Protection Fund (“IEPF”), a fund constituted by the Government of India under Section 125 of the Act.

Please note that once the shares are transferred to the IEPF, no claim shall lie against the Company or the RTA in respect thereof. However, you may thereafter claim the said shares (including all benefits accruing thereon, if any) by making an application to the IEPF Authority in Form IEPF-5, in the manner prescribed under the IEPF Rules.
